

THIS COUNSELING AFFORDS THE PARTICIPANTS TO LEARN BETTER COPING MECHANISMS ENHANCE THEIR COMMUNICATION AND BUILD A STRONGER FAMILY BOND. OF THE 402 TOTAL COUNSELING SCHOLARSHIPS MANAGED THROUGHOUT FY20 (I.E., 213 NEW AND 189 CARRIED OVER FROM FY19), 38% WERE OR MILITARY SERVICE MEMBERS OR VETERANS, 24% FOR SPOUSES, 11% FOR COUPLES, 4% FOR FAMILY, AND 23% FOR CHILDREN OF SERVICES MEMBERS OR VETERANS.
